#### **New Chair for European Banking Industry Committee**

The Secretariat will be run by the European Banking Federation, with a view to rotating again after one year.

Founded in 2004, EBiC is committed to providing the common voice of the EU banking sector at large regarding EU financial legislation initiatives and banking practices and to maintaining an open and fruitful dialogue with the EU institutions and international bodies. EBiC is an advisory committee which is regularly called upon to provide expertise in the field of financial services.

The Committee is currently focusing on initiatives in the areas of prudential supervision, the switching of banks accounts, FATF Proliferation Financing Policy Opinions, Bank accounts Switching Principles and others.
